## 7-ELEVEN & TRANSFUND 2018 SWEEPSTAKES Promotional Giveaway Summary

Use your TransFund card to complete an ATM cash withdrawal transaction at any of the TransFund Automated Teller Machines located inside the Oklahoma City metro-area 7-Eleven Stores on or between December 30, 2017 and December 28, 2018 to win a one thousand dollar (\$1,000.00) 7-Eleven gift card (a "Prize").

Alternative methods of entry are described below, no purchase or obligation is necessary to enter to win. A total of fifty-two (52) one thousand dollar (\$1,000.00) gift cards will be given away during 2018 (the "Sweepstakes").

## 7-ELEVEN & TRANSFUND 2018 SWEEPSTAKES Official Rules

## NO PURCHASE, TRANSACTION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION.

- **1. Who May Enter:** (a) At the time of your entry, you must be at least 18 years of age and be a legal resident of the United States.
- (b) Full and part-time employees of 7-Eleven Stores and TransFund ("Sponsors"), their parent companies, affiliates, distributors, subsidiaries, advertising and promotional agencies, suppliers of promotional materials and services (collectively "Sponsor Affiliates"), and financial institution clients of TransFund ("TransFund Customers"), and each of Sponsor Affiliates' and TransFund Customers' immediate family members (spouses, children, parents, in-laws and siblings) and persons residing in their homes may not be eligible to enter or win.
- **2. How To Enter and Play:** (a) NO ACTUAL PURCAHSE OR TRANSACTION IS REQUIRED to enter the Sweepstakes. Winner need not to be present to win but must prove eligibility. The odds of winning are dependent on the number of entries. Current TransFund cardholders ("Current Cardholders") may play the games hereinafter described below. Persons that do not have a TransFund card ("Non-Current Cardholders") may also play the games pursuant to the procedures described below.
- (i) Automatic Entry: To enter the Sweepstakes, a Current Cardholder may use his or her TransFund card to complete an ATM cash withdrawal transaction at any of the TransFund Automated Teller Machines located inside the Oklahoma City metro-area 7-Eleven Stores. Incomplete transactions are not eligible. There is no limit to the number of times a Current Cardholder may enter using this method. Alternatively, if a Current Cardholder does not wish to make an ATM cash withdrawal as a means to enter the Sweepstakes, the Current Cardholder may enter the Sweepstakes by using the alternative method of entry below.
- (ii) Alternative Method of Entry: To enter the Sweepstakes to win a Prize, anyone may enter by regular mail by printing the words "7-Eleven & TransFund 2018 Sweepstakes Entry." Along with his or her name, street address, city, state, zip, and phone number on a 3" by 5" white index card. Mail First Class in a #10 envelope via the U.S. Postal Service to 7-Eleven & TransFund 2018 Sweepstakes, c/o TransFund, P.O. Box 2300, Tulsa, OK 74192. Each individual entry must be hand written and mailed in a separate envelope and must be postmarked on or after December 30, 2017 and received by TransFund between January 1, 2018 and December 31, 2018. A limit of one mail-in entry per day, per postmark date, will be electronically transcribed and entered into the Sweepstakes. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Entries that are mechanically reproduced, copied, illegal, incomplete or inaccurate are void.
- **3. Prizes:** Fifty-two (52) \$1,000 7-Eleven Gift Cards will be awarded during the Sweepstakes. The first drawing will be on or about Monday, January 8, 2018, and there will be one drawing on or about each Monday for the remainder of the year for a total of fifty-two (52) drawings, with the final drawing being held on or about December 31, 2018. Winners will be drawn at random from eligible entries received during the prior week (seven day period beginning on Saturday and ending on Friday). For example, the drawing held on January 15, 2018 will be from all eligible entries received on and between January 6, 2018 and January 12, 2018. The odds of winning are dependent on the number of eligible entries received during the applicable week. Winner need not to be present to win but must prove eligibility.

- **4. Notification Of Winners:** After each drawing, the winner will be notified by mail at the address shown in the record associated with their TransFund Card, in the case of Current Cardholders, or at the address shown in their mail-in entry, in the case of Current and Non-Current Cardholders. This notification will contain the 7-ELEVEN & TRANSFUND 2018 SWEEPSTAKES AGREEMENT and W-9 for signature by the winner. Upon, and only upon, the winner's execution and return of the 7-ELEVEN & TRANSFUND 2018 SWEEPSTAKES AGREEMENT and W-9 to TransFund, TransFund will, at TransFund's sole option, either mail the Prize or make arrangements for personal delivery or pick up of the Prize. Winners will have fourteen (14) days from notification to accept the Prize. The sponsors are not responsible for, or liable for, any inaccuracy in any information supplied by any entrant. Allow 8 weeks for delivery of Prize following completion of winner verification.
